- As the computer can become hot during operation, keep it away from items that are sensitive to heat.

Maintenance

To clean the LCD panel

- To remove dust or dirt, do not use a cloth to rub it off since it may leave scratch on the screen. Use a fine brush to sweep dust or dirt, then wipe with a dry soft glass-cleaning cloth.
- To clean the oily surface, use a soft gauze dipped in camera lens cleaner, and then wipe with a dry soft glass-cleaning cloth.

Handling and Maintenance

To clean areas other than the LCD panel

Wipe with a soft dry cloth such as gauze. When using detergent, dip a soft cloth in water-diluted detergent and wring it thoroughly.

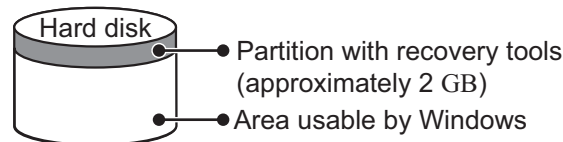


